## Minutes of The Warrior Run Council Meeting December 11, 2017

The Warrior Run Council Meeting of 12/11/2017 was held at the Warrior Run Borough Building, Front and Hanover Streets, Warrior Run, PA.

The meeting was called to order by Luke Matthews, who led The Pledge of Allegiance.
Roll Call: Rick Kratz, Matt Pilch, Sandra Wegrzynowicz, and Larry Carbohn.

The Minutes of the Council Meeting of 11/13/2017 were read by Thomas Kneidinger. The Treasurer's Report from 11/14/2017 to 12/11/2017 was given.

A motion to accept the Minutes and The Treasurer's Report was made by Larry Carbohn, seconded by Sandra Wegrzynowicz, and passed by 5 yes.

COMMUNICATIONS: The Mayor read a resignation letter dated 12/07/2017 from Mary Ann Ozmina, a Crossing Guard. There was a motion by Sandra Wegrzynowicz to hire Theresa Owens as a Crossing Guard, seconded by Rick Kratz, and passed by 5 yes.

OLD BUSINESS: Rick Kratz brought up the issue of methods that could be used to get residents who are in arrears on their sewer O&M bills, to reduce the amount that is owed to the Borough. Several methods of collection were discussed, including a change in the current Borough contract with Wyoming Valley Sanitary Authority (WVSA). No conclusions were reached in this matter.

Rick Kratz made a motion to have a police investigation of the disposal of Borough scrap materials by the Roadmaster. There was no second on the motion.

NEW BUSINESS: There was a discussion of road repair on certain streets in the Borough. The issue of potential water problems in the Borough was discussed. No conclusions were reached on these matters.

Mayor Dolores Mynes expressed herself regarding her four years as mayor.

ATTORNEY AREGOOD'S REPORT: Attorney Aregood reported that he has nothing

to report on the Deborah Shannon or Keith Urbanski lawsuits against the Borough.

Attorney Aregood stated he would put a legal advertisement in the newspaper regarding

the special Council Meetings to be held on 12/27/2017, and the Re-Organization Meeting on

01/02/2018.

POLICE REPORT: The Hanover Township Police Department for the month ending on

11/30/2017 was read by the Mayor. There were 23 calls with 34.6 man hours to handle these

calls. These hours do not include time spent patrolling the Borough.

MAYOR'S REPORT: The Mayor stated the Hanover Police Department has received a

grant from The Pennsylvania Department of Transportation. This grant will allow the Hanover

Township Police to enforce speed limits and safety belt laws. These enforcement procedures

would take place on Hanover and Front Streets in the Borough.

PUBLIC COMMENT: A resident questioned whether the Sugar Notch Police

Department would be considered, in the future, for police protection in the Borough. No specific

answer was given to this question.

A motion to adjourn was made by Larry Carbohn, seconded by Matt Pilch, and passed by

5 yes.
