An ordinance of the Borough of Warrior Run, County of Luzerne, Commonwealth of Pennsylvania fixing the tax rate for the fiscal year 2022.

NOW, it is hereby ORDAINED and ENACTED by the Borough of Warrior Run, County of Luzerne, Commonwealth of Pennsylvania; that:

SECTION 1: A tax be and the same is hereby levied on all property within the Borough of WARRIOR RUN subject to taxation for the Borough purposes for the fiscal year 2022 as follows:

GENERAL PURPOSES: One and nine tenths (1.9) Mils on each Dollar of assessed valuations.

Making a total tax rate for all Borough purpose of one and nine tenths (1.9) Mils.

SECTION II: Any Ordinance, or part of an Ordinance conflicting with this Ordinance be the same are hereby repealed in-so-far as the same affects this Ordinance.

An ordinance of the Borough of Warrior Run, County of Luzerne, Commonwealth of Pennsylvania, reenacting its occupational privilege tax ordinance, to provide revenue by imposing a tax of ten (\$10.00) dollars on occupations engaged in by individuals for the privilege of engaging in said occupations within the corporate limits of the Borough of Warrior Run, without substantial change, having been enacted under the authority granted and being reenacted under the local tax act of 1965, Act 511 effective January 1, 1966 for 2022.

NOW, it is hereby ORDAINED and ENACTED by the Borough of Warrior Run, County of Luzerne, Commonwealth of Pennsylvania, that:

SECTION 1: The Borough of Warrior Run County of Luzerne and Commonwealth of Pennsylvania, imposes a tax of Ten (\$10.00) Dollars on occupations engaged by individuals for the privilege of engaging in said occupations within the corporate limits or WARRIOR RUB BOROUGH under authority granted by the Local Tax Enabling Act, Act 511 of 1965, effective January 1, 1966 and its amendments. This is a continuance and reenactment of its prior Occupational Privilege Tax Ordinance.

SECTION II: Any Ordinance, or part of an Ordinance conflicting with this Ordinance be and the same are hereby repealed in-so-far as the same affects this Ordinance.

#### **Attorney Aregood Topics:**

- 1. Attorney Aregood stated a hearing is scheduled with Magistrate Halesey concerning Herbert Wooton properties, January 11,2022. This will take place at the magistrate's office.
- 2. Attorney Aregood stated that the Deborah Shannon case has been dismissed due to lack of action. The case has been removed from the court of common pleas docket.
- 3. Attorney Aregood confirmed Mr. Leipart is in the process of being cited again by the borough's code enforcement officer for the poor condition of his property.
- 4. Attorney Aregood stated that he reviewed the Wyoming Valley Sanitary Authority and Pa. American Water shut-off agreements approved by Council. These agreements would be used in legal proceedings against Borough residents with delinquent sewer bills. W.V.S.A. and the Pa. American Water have no legal issues with these agreements.
- 5. Attorney Aregood informed Council of a Repository Sale offer for the property on 498 Beaumont Street. He recommended that the Borough take no action in this matter and let the sale of the property proceed.
- 6. He provided information on a bankruptcy filing for 532 Front Street property. It was determined that this property was purchased by a contractor in Mountain Top. They have been cited for property maintenance.
