AMENDMENT TO THE JUNK MOTOR VEHICLE ORDINANCE (Ordinance 10-2006)

AN ORDINANCE OF THE BOROUGH AMENDING ORDINANCE 10-2006 PROVIDING FOR NOTIFICATION TO AN OWNER OF A VEHICLE IN VIOLATION OF ORDINANCE 10-2006 BY ALLOWING THE VEHICLE TO BE POSTED WITH A NOTICE OF THE VIOLATION IN ACCORDANCE WITH THE REMAINING TERMS OF ORDINANCE 10-2006.

WHEREAS, the Borough wishes to amend Section 6 of Ordinance 10-2006 entitled "Junk Motor Vehicles" to allow for notification to the owner of a vehicle in violation of the Ordinance by placing a sticker upon the vehicle which provides notice of the violation, more specifically the information contained in Section 6 (a) through (f);

THEREFORE, BE IT ORDAINED AND ENACTED and IT IS HEREBY ORDAINED AND ENACTED by Borough Council as follows:

SECTION 6 of Ordinance 10-2006 shall be amended to read as follows:

SECTION 6. Notice of Removal. Whenever the Borough finds or is notified that any junked motor vehicle or motor vehicle accessories have been stored or permitted to remain on any private property or public street or highway within the Borough and in violation of the provisions of this Ordinance the Borough shall by posting notice on the vehicle, or by sending by certified or registered mail a notice to the owner of record or person having custody of such motor vehicle or accessories, if such owner can be ascertained by the exercise of reasonable diligence, and also to the owner of the private property, as shown on the tax assessment records of the Borough, on which the same is located, to remove the junked motor vehicle, trailer or motor vehicle accessories within thirty (30) days. Such notice shall contain the following additional information.

- A. Nature of complaint,
- B. Description and location of the motor vehicle and/or motor vehicles accessories;
- C. Statement that the motor vehicle or motor vehicle accessories shall be removed from the premises no later than thirty (30) days form the date of notification.

- D. Statement that removal from the location specified in the notification to another location upon which storage is not permitted is prohibited and shall subject the person to additional penalties;
- E. Statement that if removal is made within the time limits specified, notification thereof shall be given in writing to the Borough, and;
- F. Statement of the penalties provided for non compliance with such notice.

If the owner cannot be determined, the Borough shall post notice on the vehicle. If the vehicle is not removed within thirty (30) days, the Borough may declare the vehicle abandoned and may remove the vehicle to a Borough storage facility.
